



## CORE DOOR 30-DAY TEST DRIVE

- Buy any Bestop Core Door product (Core Doors, uppers, mirror cups, mirrors) from a participating Authorized Bestop Dealer from **9/9/19 - 12/31/19**.
- If at any point within 30 days of purchase you are not happy with the qualifying product(s), you may return it to original participating dealer with your original sales receipt and completed 30-Day Test Drive Return Form.
- The participating dealer will refund the purchase price, including tax.

## DETAILS

- Offer applies to qualifying SKUs. See full list here.
- Offer excludes purchases made through non-authorized resellers.
- The Bestop products must be returned with its original packaging, with all hardware, within 30 calendar days of the official purchase date displayed on the sales receipt. This offer is available only to the original purchaser and is non-transferable. Maximum one of each SKU per person.
- Consumer receives refund amount equal to price of qualifying product(s) plus tax. Installation or shipping charges are non-refundable.
- Both Authorized Online and brick-and-mortar store purchases are eligible for 30-Day Test Drive. Auction sites are not eligible.
- Financed products through Bestop.com are not eligible for 30-Day Test Drive.
- Bestop is not responsible for any alterations made to Jeep in order to install (e.g., drilled holes)
- Customized painted or altered door products are not covered by 30-Day Test Drive.
- 30-Day Test Drive valid only in United States, including Hawaii and Alaska.

## RETURN PROCESS

- Consumer must return qualifying products to original place of purchase
- If purchased through Bestop.com, contact Customer Service for an RMA number prior to returning the products.
- Consumer must provide original sales receipt.
- Sales receipt must display date of purchase.
- Consumer must provide completed 30-Day Test Drive Form with receipt.
- FOR BESTOP DEALERS: All returned products must have a corresponding return receipt and completed 30-Day Test Drive Form in order for Bestop to record return and deliver credit for return. Dealers to return to Distributor for refund, RMA numbers will be provided by Bestop for qualifying 30-Day Test Drive returns.
